

AN ORDINANCE TO AMEND THE MOUNT AIRY FRINGE AREA ZONING ORDINANCE ADOPTED BY SURRY COUNTY, NORTH CAROLINA, TO ADD A SECTION SETTING FORTH THE FEES TO BE CHARGED BY THE ZONING ADMINISTRATOR OF SURRY COUNTY FOR ISSUING BUILDING PERMITS.

BE IT ORDAINED AND ENACTED BY THE BOARD OF COMMISSIONERS OF SURRY COUNTY, NORTH CAROLINA:

That Mount Airy Fringe Area Zoning Ordinance of Surry County, North Carolina recorded in Surry County ordinance book 1, at page 6, consisting of 38 pages including 7 pages of maps, is hereby amended by adding a new subsection under Article XI entitled "Administration, Enforcement and Penalties" to be Section 112.8 which shall read as follows:

- "112.8 The Zoning Administrator shall charge, and the applicant for the permit shall pay, for the permits issued by the Zoning Administrator the fees listed for the permits listed, which shall be as follows:
- For erection or installation of house trailer \$5.00
- For residence up to \$35,000 in value \$5.00
- For residence over \$35,000 in value \$7.50
- For all commercial buildings \$10.00"

This amendment to the ordinance shall become effective upon adoption.

This amendment to the ordinance is adopted at a regular meeting of the Surry County Board of Commissioners on August 21, 1978.

AN ORDINANCE TO AMEND THE MOUNT AIRY FRINGE AREA ZONING ORDINANCE ADOPTED BY SURRY COUNTY, NORTH CAROLINA, TO ADD A SECTION PROVIDING FOR THE ERECTION AND DISPLAY OF BUILDING PERMIT POSTERS FURNISHED BY THE ZONING ADMINISTRATOR OF SURRY COUNTY AT CONSTRUCTION AND ERECTION SITES.

BE IT ORDAINED AND ENACTED BY THE BOARD OF COMMISSIONERS OF SURRY COUNTY, NORTH CAROLINA:

That Mount Airy Fringe Area Zoning Ordinance of Surry County, North Carolina recorded in Surry County ordinance book 1, at page 6, consisting of 38 pages including 7 pages of maps, is hereby amended by adding a new subsection under Article XI entitled "Administration, Enforcement and Penalties" to be numbered Section III.1 which be as follows:

"III.1 Building permit posters shall be erected and displayed at each construction site or installation site by the recipient of the permit and poster. The Zoning Administrator shall furnish the permit poster to be displayed and erected at each site."

This amendment to the ordinance shall become effective upon adoption.
