

**AMENDMENT TO THE MOUNT AIRY FRINGE AREA ZONING ORDINANCE
AND THE OFFICIAL ZONING MAP OF THE FRINGE AREA**

UPON MOTION of Commissioner Snow, seconded by Commissioner Couch, the Board voted to approve the following:

BE IT ORDAINED by the Board of Commissioners of Surry County as follows:

SECTION I. The Mount Airy Fringe Area Zoning Ordinance and the official Zoning Map of the Fringe Area are hereby amended by changing from Residential-20 to Neighborhood Business the zoning classification of the following described property:

A portion of parcel no. 8802 of the Surry County Tax Map 5939.07, that portion beginning at an iron pin located northeast of the existing Moose Lodge Building, said iron pin being north 82°13'57" east 84.56 feet from the east rear corner of the building and north 66°32'56" east 136.83 feet from the east front corner of the building, thence from the point of beginning south 38°58'29" west 363.85 feet, thence north 52°08'29" west 90 feet thence; south 38°58'29" west 177.61 feet to a point on the northeast side of old US 52, thence with the margin of the road north 61°13'15" west 50.79 feet thence leaving the road north 38°58'29" east 185.63 feet thence north 52°08'39" west 73.01 feet thence north 45°57'32" east 389.46 feet to an iron pin, thence south 44°37'41" east 166.64 feet to the point of beginning.

SECTION II. This amendment shall be effective from and after its adoption.
