Admission Fees or Pre-event ticket sales of any kind may not be charged without approval from the Surry County Parks & Recreation Department.

V. GENERAL INFORMATION (please read and review carefully)

1. Surry County Government agencies requesting use of facilities will not be charged.
2. Picnic Shelter, Amphitheater & Horse Ring, **non- tournament rentals must be paid in full on the last business day prior to your reservation date and time or the reservation will be released.**
3. Picnic Shelter, Amphitheater & Horse Ring rentals for the next calendar year may not be made prior to November 1 of the current year and may not be made for more than one calendar year in advance.
4. Groups reserving park facilities must register with the Surry County Parks & Recreation Department by signing the proper forms and providing payment. Groups reserving fields and dates for tournaments and/or special events must also provide proof of insurance coverage (minimum of \$1,000,000 liability insurance) at the time of reservation. Persons reserving the shelters or fields must be 21 years of age or older. Groups using park facilities will abide by all Fisher River Park Rules and Regulations and will be provided a copy prior to use.
5. The Surry County Parks & Recreation Department reserves the right to prioritize scheduling in the following manner. First consideration is given to departmental, county or school sponsored activities, events and programs; then affiliated organized youth leagues; and then organized adult leagues.
6. Park reservation fees are non-refundable. Every effort will be made to schedule an alternate date should a cancellation become necessary. Alternate dates may or may not be available depending upon other reservations that have been confirmed. **In case of inclement weather, the park user has two working days to call and notify.** Reservations are eligible for up to one year of original reservation date. Reservations extending into the following year can be made no earlier than November 1st.

VI. HOURS OF OPERATION

Playground, Amphitheater/River bottom & all Trails

8:00 am – dark (year round)

Athletic Complex

March 1- October 31, 8:00am - 10:00pm

November 1 - February 29, 8:00am - 6:00pm

(Extension of hours available for additional \$10 per hour)

Fisher River Park will be closed each year on Thanksgiving Day and Christmas Day. Gates are locked at closing.

Fisher River Park Athletic Complex features 3 baseball/softball fields (one 325' field and two 300' fields), a regulation size soccer field, a peewee soccer field, 1 ½ mile of wooded walking trails, ¼-mile paved walking track, Amphitheater, picnic shelters, Sensory Garden, horse arena, playground equipment for children ages 2 –5 and equipment for children ages 5-12, horseshoe pits, a sand volleyball court, mountain bike trail, concessions and clean public restrooms. Fisher River Park is staffed and a park attendant will be available to assist you.
