Admission Fees or pre-event ticket sales of any kind may not be charged without prior approval from the Surry County Parks and Recreation Department.

**GENERAL INFORMATION (PLEASE READ AND REVIEW CAREFULLY)**

1. **Reservation fees for shelters must be paid at the time the reservation is scheduled and are non-refundable.** Every effort will be made to schedule an alternate date should a cancellation become necessary, or in case of inclement weather. Alternate dates may or may not be available depending upon other reservations that have been confirmed. In case of inclement weather, the park user has two working days to call and schedule an alternate date.
2. Surry County Government agencies requesting use of facilities will not be charged.
3. Amphitheater and Horse Ring non-tournament rentals must be paid in full on the last business day prior to your reservation date and time or the reservation will be released.
4. No reservation for any of the facilities at Fisher River Park may be made more than one calendar year in advance.
5. Groups reserving park facilities must register with the Surry County Parks and Recreation department by signing the proper forms and providing payment. Groups reserving fields and dates for tournaments and/or special events must also provide proof of insurance coverage (minimum of \$1,000,000 liability insurance) at the time of reservation. Persons reserving the shelters or fields must be 18-years-of-age or older. Groups using park facilities will abide by all Fisher River Park rules and regulations.
6. The Surry County Parks and Recreation department reserves the right to prioritize scheduling in the following manner: First consideration is given to departmental, county or school sponsored activities, events, and programs; then affiliated organized youth leagues; and then organized adult leagues.

**HOURS OF OPERATION**

**Shelter Hours are based on sunrise and sunset. Shelters will be unavailable based upon daylight and dark.**

Fisher River Park is open daily and year round. The park is closed **Thanksgiving Day** and **Christmas Day**. Gates are locked at closing and any vehicles left inside the fenced parking areas will be locked in and considered trespassing.
