Parcels of land are mapped by legal description found on recorded deeds, recorded plats, and by probated estates established by will. Ownership names on parcels of land may be changed only by recorded deeds. Contiguous parcels that are recorded under the same ownership name may be mapped as a single parcel for property taxation purposes without a recorded deed only if this request is signed, notarized, and submitted to the Surry County Tax Administration. This action **MUST** be approved by the Surry County Planning Department prior to the combination process. This procedure does not affect such things as insurance, mortgages, legal descriptions, or any other information indicated by deed.

LIST THE PARCELS BY PARCEL IDENTIFICATION NUMBER (PIN) WITH DEED BOOK AND PAGE NUMBER THAT CORRESPONDS TO EACH PARCEL.
